The premium paid by governments was recalculated. The maternity benefit was enforced from July 2011.

2. The premium paid by the insured persons is calculated proportionally by the actual insured days from Jan. 2012.

<sup>3.</sup> The grand total means the sum of the persons receiving pensions at the end of the recent year and the

accumulation of the persons receiving maternity and funeral benefit.

4.From Jan. 2012, adjustments will be made to payment amounts for Old-Age Pension Payment, the Old-Age Basic Guaranteed Pension Payments, Indigenous people payment and guaranteed annuity payment amounts for Survivor Pension Payment will be adjusted to NT\$3,500; guaranteed annuity payment amounts for Disability Pension Payments and the Disability Basic Guaranteed Pension Payments will be adjusted to NT\$4,700.
