Note : 1.Labor to apply for monthly pension was approved for the first time, since receipt of the application for the following month until issued to the quarter ended, after a regular basis every Feb., May, Aug., Nov. quarterly payment. The cases of monthly pension include first issue and following issue. The total cases are calculated from Oct. to Dec., and the cases of first issue are calculated for the whole year.

2.The grand total cases of labor pension means the sum of the persons receiving monthly pension payments at the end of the recent year and the total cases of the lump-sum pension payments.
