Note : 1. After National Pension Act amended on July 1, 2011, according to paragraph 6, Article 13, the premium paid by government have been recalculated. The premium paid by government should be afforded on May and Nov. The data include the premium of insured person who suffered from disasters from Dec. last year to Nov. current year.
2. The grand total means the sum of the persons receiving pensions at the end of the recent year and the total persons of the lump benefits.
3. Payments of insurance are paid by National Pension Fund. Difference of pension are assumed by the central competent authority. Basic guaranteed pension (including Old-age basic guaranteed pension, Indigenous people payment and Disability basic guaranteed pension) are paid by the budget of central competent authority.
4. The data of National Pension of this Yearbook doesn't include the re-examination expense.
